PRESS ACCREDITATION REGULATION 1000 MIGLIA 2020

ACCREDITATION REQUEST METHOD

Requests for press accreditation must be submitted **exclusively online**, by filling in the appropriate form, starting **from 21st September and by 4th October**, following registration in the [Press Area](#). Requests received by other means will not be taken into consideration. **It will not be possible to be accredited on site.**

REQUIREMENTS AND CRITERIA

Only journalists in possession of a valid professional card will be accredited.

Daily newspapers and periodicals must be on sale to the public (business and corporate magazines will not be accredited). Under no circumstances will advertising agencies, public relations agencies or companies be accredited as media.

Photographers and video operators are required to present the Chamber of Commerce certificate or a letter of appointment issued by the editor of a newspaper registered with the court of territorial jurisdiction, certifying their qualification as a professional.

Those who have been editing a specialist blog for at least three months may apply for press accreditation as a blogger. In this case, the request must be accompanied by the presentation of the Chamber of Commerce certificate or the letter of appointment, as well as the presentation of the publishing project.

We hereby specify that the letter of appointment must contain the following information:

- a. name and surname of the person appointed to follow the event;
- b. job description of the appointee;
- c. information on the newspaper;
- d. e-mail address to which notifications are to be sent;
- e. signature of the editor in charge.

It will not be possible to make press accreditation requests for third parties or multiple requests. The press accreditation, which we remind you is strictly personal, is issued only to people over 18 years of age.

ONLINE PROCEDURE

The following steps must be completed to apply for a press accreditation:

1. **Registration to the Press Area.** Registration can be made by accessing the following link: <https://login.1000miglia.it/login.php#press>. The personal data provided will be stored thus simplifying the presentation of accreditation requests. The accreditation service is free of charge and is reserved for media operators. A confirmation e-mail will be sent to the specified address.
2. **Account activation.** Registration to the portal must be activated by the user by clicking on the link in the automatic notification email. Registration to the accreditation service must be done only once.
3. **Filling in the accreditation request form.** To request accreditation, it will be necessary to access the system with e-mail and password indicated during registration to the portal. The user must then select the event of interest and upload the required documentation to the portal.
4. **Confirmation of receipt of the accreditation request.**

The acceptance of the accreditation request is totally at the discretion of the Press Office of 1000 Miglia S.r.l. Incomplete requests that do not comply with the requirements or are received after the indicated deadline will not be accepted. The notification of the outcome of the request will be made by email to the address provided during registration to the portal. It is recommended to check the receipt of the request also in the junk mail folder.



DISCLAIMER

By making the request for accreditation, you declare:

1. to be aware of the dangers inherent in the context of motoring events and in attending them. You also certify that you have the experience and professional preparation to safely attend the event and that you are committed to taking all necessary precautions to avoid physical and material damage to yourself and others;
2. to be aware that the event takes place on roads open to traffic, and consequently undertake to observe all the traffic rules laid down in the Italian Highway Code;
3. to know and accept that it is absolutely forbidden to consume (i) alcohol, starting from 6 (six) hours before the departure of each leg and until the arrival of each leg; and (ii) drugs and/or substances capable of altering psycho-physical conditions;
4. to comply with, at all times: i) the indications provided by the Organizer and to conform your conduct to these indications, ii) the security orders and the indications provided by the Race Officials and the Police;
5. to assume any and all responsibility for damages that you may suffer, due to your own imprudence or inexperience;
6. to release the Organizing Committee, the Clerk of the Course and any other person, Institution or Association from any and all responsibility for the above;
7. to release ACI SPORT, 1000 Miglia S.r.l., all persons involved in the organization of the race, the ACI organizations involved in the race, the Race Officials and the owners of the routes where the race takes place from any liability for any damage occurred to the user of the pass or produced or caused by third parties or things to the user of the pass;
8. to be aware that the accreditation and consequently any pass provided are strictly personal and to be aware that it is absolutely forbidden to give it to third parties;
9. to be aware that, due to Covid-19, access to places will from time to time be subject to compliance with the protocols in force and the maximum capacity available.

Any abuse will result in the immediate withdrawal of any car passes and stickers assigned, it will prevent the issuing of both for subsequent years and will be reported to the competent judicial authorities. Please note that the car pass and sticker remain the property of the Organizer who may withdraw them at any time.

IMPORTANT NOTE

It is forbidden to sell the photographs and videos taken during the race directly to competitors, drivers and their staff, unless expressly authorized by 1000 Miglia S.r.l.
