

## PRESS ACCREDITATION REGULATION 1000 MIGLIA 2021

### METHOD OF REQUESTING ACCREDITATION

Press accreditation requests must be submitted exclusively online, by completing the appropriate form, starting from 23<sup>rd</sup> March to 23<sup>rd</sup> May 2021, upon registration to the [Press Area](#). Requests received in other ways will not be taken into consideration. It will not be possible to register on-site.

### REQUIREMENTS AND CRITERIA

Only journalists in possession of a valid professional card will be accredited.

Paper newspapers and periodicals must be for sale to the public (business and corporate magazines will not be accredited). Under no circumstances will advertising, public relations, or corporate media agencies be credited.

For photographers and video operators, the presentation of the Chamber of Commerce registration or a letter of appointment issued by editor in Chief of the newspaper registered at the court of territorial jurisdiction, certifying the qualification of professional.

Those who have been editing a specialized blog for at least three months can apply for press accreditation as bloggers. In this case, the request must be accompanied by the presentation of the editorial project in addition to the presentation of the Chamber of Commerce registration or the letter of appointment.

It is specified that the appointment letter must necessarily contain the following information:

- a. name and surname of the person in charge who will attend the event;
- b. duty of the person in charge;
- c. information about the newspaper;
- d. e-mail address to send communications.
- e. signature of the managing director.

It will not be possible to make multiple requests or requests of press accreditation for third parties. Press accreditation is considered to be strictly personal and issued exclusively to people over 18 years of age.

### ONLINE PROCEDURE

To request a press accreditation, you need to complete the following steps:

1. **Registration to the Press Area.** Registration can be done by accessing the following link: <https://login.1000miglia.it/login.php#press>. The data provided will be stored simplifying the presentation of accreditation requests. The accreditation service is free and reserved for media operators. A confirmation email will be sent to the specified email address.
2. **Account activation.** Registration on the portal must be activated by the user by clicking on the link in the automatic email notification. Registration for the accreditation service must be done only once.
3. **Compilation of the accreditation request form.** To request accreditation, it will be necessary to access the system with the e-mail address and password indicated during registration on the portal. The user must then select the option representing his interest and upload the required documentation to the portal.
4. **Confirmation of receipt of the accreditation request.**  
The acceptance of the accreditation request is totally at the discretion of the Press Office of 1000 Miglia S.r.l. Incomplete requests that do not comply with the requirements or are received after the indicated deadlines will not be accepted. The outcome of the request will be communicated via email to the address provided during registration on the portal. It is recommended that you also check the receipt in the junk mail folder.

## **SELF-CERTIFICATION**

To withdraw the accreditation, it will be necessary to provide an active telephone number, sign a "self-declaration for Covid-19 risk" and a consent of wearing a wristband until the end of the event that certifies such subscription; without the wristband, it will be impossible to access the areas of the event despite the possession of the regular pass. The self-declaration form will be made available in the Press Area.

## **DISCLAIMER**

By applying for accreditation, you declare:

1. to be aware of the inherent dangers of car racing events and to assist in case of any misfortune. It is also certified to have the experience and professional preparation to attend the event with complete safety, to undertake all the necessary precautions to avoid physical and material damage to oneself and others;
2. to be aware that the event takes place on roads open to traffic, consequently committing to observe all the traffic rules provided for in the Italian Highway Code;
3. to know and accept that it is forbidden to take (i) alcohol, starting from 6 (six) hours before the departure of each stage and until the arrival of each stage; and (ii) drugs and/or substances suitable for altering psycho-physical conditions;
4. to respect, at all times: i) the indications provided by the Organizer and conduct accordingly to such indications, ii) the security orders and the indications provided by the Race Officers and Law Enforcement bodies.
5. to assume any liability for any damage that may be suffered, through their recklessness or incompetence;
6. to relieve the Organizing Committee, the Race Director and any other person, Institution or Association from any responsibility;
7. to relieve ACI SPORT, 1000 Miglia S.r.l, all the persons involved in the organization of the race, the ACI in any case interested in the race, the Race Officials, and the owners of the routes where the race takes place from any responsibility for any damage to the user of the pass or produced or caused by third parties or things to the user of the pass;
8. to be aware that the accreditation and, consequently, any pass provided are strictly personal and to be aware that it is forbidden to transfer it to third parties;
9. to be aware that, due to Covid-19, access to the areas of the event will be subject to compliance with the protocols in force and the maximum available capacity.

Any abuse will result in the immediate withdrawal of any pass and car tax license and will prevent the issue of both for the following years and will be reported to the competent judicial authorities. Please note that the pass and the car tax license remain the property of the Organizer who can collect the same at any time.

## **IMPORTANT NOTE**

The sale of photographs and videos taken during the race is prohibited directly to competitors, drivers, and their staff unless expressly authorized by 1000 Miglia S.r.l.

## **PROCESSING OF PERSONAL DATA**

The processing of personal data collected during the press accreditation procedures will take place under EU Regulation no. 2016/679 (so-called GDPR) and the Legislative Decree. n. 196/2003 as amended by Legislative Decree. n. 101/2018.
